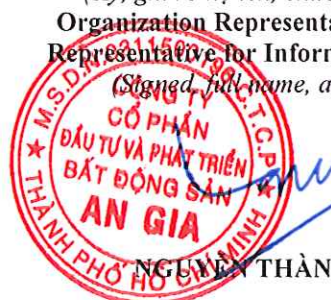

2. The SSC shall receive and process the reporting documents on the issuance in accordance with Clause 2 Article 11a of the Securities Law and Point d Clause 1 Article 6 of Decree No. **155/2020/ND-CP**, as amended and supplemented by Point b Clause 3 Article 1 of Decree No. **245/2025/ND-CP**.
3. The SSC has disclosed the receipt of the complete reporting documents on the issuance of bonus shares under the Company's employee stock option program on the SSC's website at **www.ssc.gov.vn**. The Company's plan for the issuance of bonus shares under the employee stock option program shall be implemented in accordance with Resolution No. **15/2026/NQ-AGI-DHDCD** dated **29 June 2026** of the 2026 Annual General Meeting of Shareholders, Resolution No. **19/2026/NQ-AGI-PL** dated **21 July 2026** of the Board of Directors, and applicable laws and regulations.
4. The SSC requests the Company to carry out the share issuance in accordance with Article 69 of Decree No. **155/2020/ND-CP**.
